The present conditions define the rules applicable to the admission and participation of the Exhibitors of the “Hempzon”, at Dudelange, organised by Hempzon Sarls, 47, rue Notre Dame L-3621 Kayl, here after called “Organizing Company”. The company withheld the right to modify or complete the present conditions, without prior notification, in the interest of respect and security of persons and goods. The Exhibitors will be contacted by any appropriate method.

Localization

The “Hemp Expo” will be held at route de Thionville, 3481 Dudelange, Luxembourg, at the place said: Hall Fondouq, on the 27th and 28th of June.

Opening time

Saturday, June 27:

For exhibitors: **9: 00H - 11: 00h** B2B breakfast
For visitors: **11: 00h - 20: 00h**

Sunday **June 28:**

For exhibitors and visitors: **11: 00h - 20: 00h**

Anyone will have to enter through the main entrance, in order to control the access passes and entrance tickets.

Participation in the Hempzon

Participation in the Hempzon can be requested by any company, organization or association offering products / services corresponding to the exhibition theme. The Organising Company reserves the right to refuse booking requests without having to provide reasons.

Booking request

In order to participate in the "Hempzon" in Luxembourg, the Exhibitor must send the pre-registration form and the conditions of participation to the Organising Company, duly completed and signed by a legal representative of the company or association. By submitting the pre-registration form, the signatory acknowledges as legally binding for him/her the present conditions as well as any other directives of the Organising

Company.

Booking requests presented under conditions or reservations will not be taken into consideration by the Organising Company.

When the Organising Company has accepted a reservation request, the interested party is informed by an acceptance email. It is only by this email that the Organising Company commits itself and that the participation contract becomes effective.

Payment

Once the reservation has been accepted, the Organising Company will issue a deposit invoice covering 60% of the total amount. This amount must be paid to Hempzon Sarls within 5 days of receipt of the invoice. The remaining 40% must be paid before May 1, 2020. In the event of non-payment of the full amount due, the reserved space will be cancelled and will be available for rental again.

For rentals after May 1st, the stand or space rental must be paid in full within 3 days of receipt of the invoice.

The Organising Company reserves the right in exceptional circumstances to change the ground space and/or the location of the site, without giving the Exhibitor any right to any compensation or compensation.

In the event of cancellation by the Exhibitor, Hempzon Sarls will charge the cancellation fee as follows:

- Before May 1st, 10% of the total amount
- After May 1st, 60% of the total amount

The Organising Company is in no way responsible for any material damage that the Exhibitor or his entourage may cause through their fault or negligence throughout the duration of the Fair, including the assembly and dismantling period, as well as during the transport of his materials or goods within the Fair grounds or in any of the Fair's stands.

Exhibitors are obliged to have a civil liability insurance to cover these possible inconveniences.

Distribution of the fair

The Fair will be divided into 2 areas, a space in the interior of the hall and a space under a 525m² tent. There is the possibility to rent a stand space in the inner hall, as well as in the outer tent.

The outdoor area will be composed of food, music, bar and chill areas.

Admission entries and restrictions

The entrance fee will be set at €10 per day of the fair. The pre-sale and on-site sale price will be the same.

The Organising Company will provide Exhibitors with 10 entrance tickets per stand, which may be offered to their customers or partners. These tickets will be valid for the 2 days of the Fair.

The entrance to the Fair includes access to the hall and the external parts.

The Fair is strictly reserved for adults and minors accompanied by an adult.

B2B morning (Business to Business)

On Saturday morning there will be a B2B breakfast for Exhibitors. The fair will be open from 9h-11h exclusively to exhibitors and professionals. From 11h the Fair will be open to the public.

A list of participating merchant companies will be made available to Exhibitors, to allow them to contact each other.

Exhibitors Pass

Exhibitors will be provided with three (3) "Exhibitor Pass" which will give them access to both days of the Fair, as well as to the B2B morning. The Exhibitor is required to inform the Organising Company of the persons who will be present in their stand, in order to be able to provide the badges.

Badges will be distributed to exhibitors on the day of the Fair.

Exhibitors must comply with all labour law obligations with regard to their staff employed at the Fair.

Stand rent

There are two types of stands / space rental formulas for Exhibitors:

Formula 1 Hall stand

- floor space + standard modular construction. Exhibitors will rent the space it will occupy at the Fair, as well as the basic structure of the stands which is composed of partition panels, an electrical outlet of 220W, lighting and carpet that will cover the floor of the stands. A catalogue of furniture of the parent company will be made available to the exhibitors, furniture will be charged in addition by the parent company.

Formula 2 Tent stand

- floor space + standard modular construction. Exhibitors will rent the space it will occupy at the Fair, as well as the basic structure of the stands which is composed of partition panels, an electrical outlet of 220W, lighting and carpet that will cover the floor of the stands. A catalogue of furniture from a parent company will be made available to the exhibitors, furniture will be charged in addition by the parent company.

It is possible to have an integrated stock in the stand, if needed please indicate it on your form. Additional fees will be charged.

Different types of stands possible outside and inside:

Central stand: open on all 4 sides

Stand Head: open on 3 sides

Corner stand: open on both sides

Countertop: open on one side

The installation of stands that would not have prior authorizations will be refused.

It is strictly forbidden to paint, glue, screw, nail or damage walls or floors, as well as the stand furniture provided by the Organizing Company except in cases where this has been expressly authorized by it. The Exhibitor will be responsible for all deteriorations found.

Stand assembly and disassembly

The stands will be set up from 25 to 26 June 2020 from 10 a.m.

The dismantling will take place on 28 June, after the official closing of the Fair and on 29 June from 8:00 am. The Organising Company will proceed with the removal of the compound stands (panels, carpets, etc.).

The Organising Company takes care of the cleaning, any object subscribed to on the stand will be thrown away.

The exhibitor will be held liable for any damage caused to the structures and installations made available to him.

Wireless

The Organising Company will provide Wi-Fi for the Exhibitors in the interior of the hall.

Security

The Organising Company will set up a general surveillance of the Fair 24 hours a day from Friday, 26 June at midnight, until Monday 29 June at 8:00 am.

However, the Organizing Company is not liable for damages or theft suffered from installations and exhibits. Exhibitors are responsible for monitoring their stands and products exhibited during the Fair as well as during assembly and disassembly. Exhibitors are responsible for valuables that will not be locked up.

Sale of cannabis products

Following the change in Luxembourg legislation, all cannabis products with a THC content of less than 0.3% by weight of the sample intended for smoking or vaporization or which can be used for this purpose are subject to excise duty and VAT collected at source. It is therefore necessary to be registered with the Luxembourg Customs and Excise Administration to sell cannabis products intended for smoking. (more information https://douanes.public.lu/fr/actualites/2019/Taxation_produit_base_cannabis.html)

A list of the products that you intend to sell must be provided to the Organising Company.

For "tobacco" products containing cannabis or falling under Luxemburgish excise taxes it will be necessary to provide us with the authorization number obtained by the Customs and Excise Administration. (LUN... or LUC...).

It is strictly forbidden to sell a product listed in the law of 19 February 1973 on the sale of medicinal substances and the fight against drug addiction. Thus in no case can cannabis with a THC rate higher than 0.3% can be brought to the Fair.

In order to guarantee any inconvenience during the Fair, Exhibitors are requested to have on site any documentation relating to products containing THC or based on cannabis.

The products exhibited at the Fair must have a THC rate below 0.3%. Any other cannabis product cannot be exhibited at the Fair if it is considered as "Novel Food".

The Organising Company reserves the right to request the withdrawal of the product or to close the stand in the event of non-compliance with the conditions of participation.

The Organising Company will not assume any type of liability in the event that the State police are called upon to intervene because of an offence committed by one of the Exhibitors.

Cleaning

The Organizing Company will take care of the general cleaning of the Fair, as well as the basic cleaning (removal of garbage, cleaning of exteriors). Possible waste of booths should be placed in closed bags so that the cleaning crew can pick at night. Stands must ensure that they have their own cleaning during the days of the Fair, however, they may request additional cleaning service from the Organizing Company.

Advertising at the Fair

It is forbidden to use adhesives which leave traces on the compound stands, or on any other surface that is part of the Fair. The costs of cleaning any traces will be at the expense of the exhibitors. The corridors and the entrances to the Fair must remain free of objects advertising.

No object can obstruct the halls, all objects that belong to an Exhibitor must be in his rented space.

Food

The Organizing Company will set up various food stands/trucks which will prepare delicious menus for visitors, as well as for Exhibitors. It is not authorized to the Exhibitor to selling food, in the case of selling hemp food, please do a request to the Organizing Company.

Music and image diffusion in the stands

Exhibitors located inside the fair will not be permitted to broadcast music. There will be music organized by the Organizing Company, if necessary. He will not be allowed to disseminate images that could harm the right to honour, the right to image, to the personal and familiar likeness of a natural person or a legal person.

Prohibitions

Exhibitors and visitors are forbidden to:

- Use flammable, toxic or dangerous products
- Produce smoke, flames, sparks or hot temperatures
- Use unallocated power outlets
- Use drones within the fair
- Anything that can cause a fire hazard

It is strictly forbidden¹ to smoke and vape in the party interior of the fair, it will be possible to smoke and vape in the outer part of the Fair. The Organizing Company will try to organize a smoking area. This prohibition Smoking and vaping counts for visitors and for exhibitors. This smoking prohibition extends from the day of assembly, to the day of dismantling of the stands. A violation of this prohibition may result in the withdrawal of the Exhibitor Pass, or the expulsion of the visitor from Fair.

Applicable legislation

Luxembourg law applies. In case of dispute between the Exhibitor and the Organizing Company the courts of Luxembourg will be competent.

Nullity

If one or more provisions of these general terms and conditions are held to be invalid or declared as such pursuant to a law, regulation or following a final decision of a competent court, the other provisions shall retain their full force and scope.
